Depending on the project's location and size, different permits may be needed to install solar panels. Typical permit kinds are as follows: Obtaining a building permit guarantees that the installation adheres to regional building regulations and requirements.

Do I need permission to install solar panels on my roof?

General conditions to be aware of With roof-mounted installations, other than the solar panels and brackets themselves, if you're planning on installing any other solar PV equipment on the roof of the building, then you'll need the Prior Approval (56 days) of the Local Planning Authority.

Do I need planning permission for my commercial solar installation?

You will probably need planning permission for your commercial solar installation if any of the following circumstances apply: Now, it's worth remembering that if your commercial solar panel installation falls into one of the categories above, that doesn't necessarily mean that your planning application will be rejected off the cuff.

Do commercial solar panels need development rights?
