Can a solar PV system be installed on a village house?

Solar PV systems not more than 2.5 metres in height (Note 1) may be installed on the rooftops of village houses exempted under the Buildings Ordinance (Application to the New Territories) Ordinance (BO (ANT)O) without prior permission from the Lands Department and the Buildings Department (BD).

Will New Territories 'village houses' be able to install solar panels?

Question: The Government indicated in the 2018 Policy Address that it would suitably relax the restrictions on installation of solar photovoltaic (PV) systems on the rooftops of New Territories Exempted Houses (commonly known as 'village houses').

Does a new home need a solar PV system?

Under state Building Energy Efficiency Standards, any new residential construction up to three stories tall must include a solar PV system sized to meet a portion of the home's expected energy use. This rule took effect in 2020, making solar energy a standard feature of new single-family homes and low-rise apartments.

Can a power company sell a solar PV system?

Individuals and organisations may apply to the power companies and install RE systems (including solar PV systems), and sell the RE generated to the power companies at a rate higher than the normal electricity tariff rate.
