In our experience, most utility-scale solar projects use an EPC Contract. An operation and maintenance agreement: This is usually a medium- to long-term Operating and Maintenance Agreement (O&M Agreement) with an Operator. The term of the O&M Agreement will vary from project to project.

How does a solar PV O&M contract work?

o Asset Management Agreement A common contractual framework for solar PV O&M is the "fixed price" model for a specified scope of work that can include administrative, operational, and Preventive Maintenance tasks. A "cost plus" element can then be added for Corrective Maintenance or additional services.
